PUBLC CONSULTATION QUESTIONNAIRE ON THE REVIEW OF THE POLICE ACT 1964:

Between 2014 to 2016, The Law Reform Commission undertook a project to review the Police Act, 1964. A subcommittee was established with the mandate to "to review the Police Act of 1964 taking into consideration any pertinent provisions in the Constitution of Sierra Leone, relevant case law and legislation from other jurisdictions, the views and recommendations of any interested stakeholders, and any other source the Sub-committee considers relevant". The subcommittee held several meetings and concluded with the writing of a report that contained recommendations.

This project was revived in 2023 by the reconstitution of a subcommittee to continue the mandate of the 2014 subcommittee.
