Act, 1966**

**Being an Act to make the necessary Amendments in the Legislation
relating to Local Authorities consequent on the alteration
of their Financial Years to coincide with that of the
Government**

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with
the advice and consent of the House of Representatives in this
present Parliament assembled, and by the authority of the same,

1. The Freetown Municipality Act, the Rural Area Act, the Sherbro Urban District Council Act, the District Councils Act, the Bo Town Council Act, and the Townships Act are hereby amended by substituting in the provisions of those enactments as set out in the First Column of the Schedule, for the dates set out in the Second Column thereof opposite each such provision the corresponding dates set out in the Third Column thereof, wherever such dates occur in those provisions.
