THE NON-CITIZENS (REGISTRATION, IMMIGRATION AND EXPULSION) ACT, 1965 (Act No. 14 of 1965)

THE NON-CITIZENS (REGISTRATION) (AMENDMENT) RULES, 2006 Short title.

In exercise of the powers conferred on him by section 40 of
Non-Citizens (Registration, Immigration and Expulsion) Act, 1965,
the President hereby makes the following Rules:—

1. These Rules shall be deemed to have come into operation on the 1st day of January, 2006. Commence-
ment.

2. The Non-Citizens (Registration) Rules, 1967 are hereby amended as follows:— Amendment
