The 1984/85 Appropriation Act, 1984

Short title.

Being an Act to provide for the Service of Sierra Leone for the year 1984/85

[1st July, 1984]

Date of commencement.

WHEREAS it is necessary to make provision for the Service of Sierra Leone for the year 1984/85:

BE IT THEREFORE ENACTED by the President and Members of Parliament in this present Parliament assembled, as follows:—

1. This Act shall be deemed to have come into operation on the 1st day of July, 1984.
