**The 1967/68 Supplementary Appropriation
Decree, 1968**

Short title.

**Being a Decree to make Supplementary Provision for the service
of Sierra Leone for the Year 1967/68**

WHEREAS by the 1967/68 Appropriation Decree, 1967, a sum not exceeding thirty-two million, five hundred and ninety-three thousand, eight hundred and sixty eight Leones was provided for the service of Sierra Leone for the year nineteen hundred and sixty-seven/sixty-eight:

AND WHEREAS it has become necessary to provide for expenditure from the Consolidated Revenue Fund of a further sum of Four hundred and fifty-one thousand, Nine hundred and eighty-three leones in excess of the provisions in the above cited Decree for the several services set forth in the first and second Schedules hereto:

AND WHEREAS by virtue of the powers vested in him by Rule 2 of Part II of the Second Schedule of the Finance (Control and Management) Act, 1961, as adapted by the Proclamation entitled "Administration of Sierra Leone (National Reformation Council) Proclamation 1967" the Member of the National Reformation Council responsible for the Department of Finance has by Warrant authorised the issue from the Contingencies Fund of the sum totalling one hundred and ninety-nine thousand five hundred leones under the various Heads set out in the Second Schedule hereto, which expenditure could not without serious injury to the public interest have been postponed until provision could be made by a Supplementary Appropriation Decree:

AND WHEREAS it is expedient that all withdrawals from the Contingencies Fund shall be reported to the National Reformation Council so that, that fund shall be restored to the amount appropriated under section 18 of the Finance (Control and Management) Act, 1961, by inclusion of appropriations thereto by a Supplementary Appropriation Decree:

NOW THEREFORE PURSUANT to the Proclamation entitled "Administration of Sierra Leone (National Reformation Council) Proclamation 1967", published in the *Gazette* on the 25th March, 1967, the National Reformation Council hereby makes and issues the following Decree:—

1. This Decree shall be deemed to have come into operation on the 1st day of February, 1968.

2. The sum of four hundred and fifty-one thousand, nine hundred and eighty-three leones shall be and is hereby granted to Her Majesty the Queen, Her Heirs and Successors, for and during the year nineteen hundred and sixty-seven/sixty-eight to be applied for the several services set forth in the First and Second Schedules.

3. The said sum of four hundred and fifty-one thousand nine hundred and eighty-three leones shall be and is hereby declared to be charged upon and made payable from and out of the Consolidated Revenue Fund for the year nineteen hundred and sixty-seven/sixty-eight and the payment thereof shall be taken to begin immediately after the commencement of this Decree:

Provided that in the case of the sums authorised by the Member of the National Reformation Council responsible for the Department of Finance to be issued from the Contingencies Fund the payment thereof shall be taken to have begun on the date of the Warrant authorising such payment.

4. The Accountant-General is hereby authorised and required from time to time upon the Warrant or Order of the Member of the National Reformation Council responsible for the Department of Finance to pay out of the Consolidated Revenue Fund—

Accountant-General's authority to pay.

- (a) the sum of two hundred and fifty-two thousand four hundred and eighty-three leones for the services specified in the First Schedule; and
- (b) the amount of one hundred and ninety-nine thousand and five hundred leones already paid into the Consolidated Revenue Fund from the Contingencies Fund under Warrant issued by the Member of the National Reformation Council responsible for the Department of Finance under the provisions of Rule 2 of the Contingencies Fund Rules 1961, for the services specified in the Second Schedule,

during the year ending on the thirtieth day of June, nineteen hundred and sixty-eight.

5. The Accountant-General is also hereby authorised and required upon the Warrant or Order of the Member of the National Reformation Council responsible for the Department of Finance to pay from the Consolidated Revenue Fund into the Contingencies Fund the sum of one Hundred and ninety-nine thousand and five hundred leones in reimbursement of the sums withdrawn from the Contingencies Fund for the services set out in the Second Schedule.

Reimbursement of Contingencies Fund.

6. The amount from time to time paid for and in respect of the expenditure authorised in section 2 shall not exceed in gross the sum of six hundred and fifty-six thousand two hundred and sixty-three leones during the year ending on the thirtieth day of June, nineteen hundred and sixty-eight, and any balances remaining unissued at the end of June, nineteen hundred and sixty-eight, shall lapse and shall not be available for making payments in the following years.

Balance at 30th June 1968 to lapse.
