The National Provisional Ruling Council (Establishment Short title.  
of Office of Principal Liaison Officer) Decree, 1992

[14th July, 1992] Date of Commencement.

PURSUANT to paragraph 3 of the Proclamation entitled "The Administration of Sierra Leone (National Provisional Ruling Council) Proclamation, 1992", published in the *Gazette* on the 4th day of May, 1992, the National Provisional Ruling Council hereby makes and issues the following Decree:—

- 1. This Decree shall be deemed to have come into force on the 14th day of July, 1992. Commencement.

Establishment of office of Principal Liaison Officer,

2. (1) There is hereby established the Office of PRINCIPAL LIAISON OFFICER.

Functions of Principal Liaison Officer,

(2) The National Provisional Ruling Council may appoint from amongst its members such number of Principal Liaison Officers as the Council may think fit.

Allowances, etc,

3. A Principal Liaison Officer shall be responsible for supervising, monitoring and co-ordinating the operations of any Department of State or such other business of Government, as may from time to time be assigned to him by the National Provisional Ruling Council.

Oath of office,

4. A Principal Liaison Officer shall be entitled to such allowances and other incidents of office as may be prescribed by the National Provisional Ruling Council.

5. A Principal Liaison Officer shall take and subscribe the Oath of Office as set out in the Schedule hereto.

### FIRST SCHEDULE

"I do hereby (in the name of God/Allah swear) (solemnly affirm) that I will faithfully and truly discharge the duties of the Office of Principal Liaison Officer of the Republic of Sierra Leone, and that I will support, uphold and maintain the provisions of the Administration of Sierra Leone (National Provisional Ruling Council) Proclamation, 1992 (Public Notice No. 20 of 1992) and the provisions of the Constitution of Sierra Leone, 1991 which are not inconsistent with the Proclamation. (So help me God/Allah)."
