THE LOCAL AUTHORITIES (COMMITTEE OF MANAGEMENT FOR THE FREETOWN CITY COUNCIL) ORDER, 1986

In exercise of the powers conferred upon the President by Section 2 of the Local Authorities (Miscellaneous Provisions) Act, 1965 (Act No. 50 of 1965) and acting in accordance with the advice of the Cabinet the President hereby makes the following Order:

1. This Order shall be deemed to have come into force on the 31st day of October, 1986.

2. With effect from the commencement of this Order the Freetown City Council constituted under the Freetown Municipality Act, 1973 (Act No. 20 of 1973) shall cease to exercise or perform its powers and duties under that Act.

3. With effect from the commencement of this Order the following Committee of Management is hereby appointed for the purpose of exercising and performing the powers and duties of the Freetown City Council under the Freetown Municipality Act, 1973 (Act No. 20 of 1973):—
