**Being a Decree to provide for the service of Sierra Leone for the
year 1992 to 1993**

**[1st July, 1992] Date of
Commence-
ment.**

WHEREAS it is necessary to make provision for the service of
Sierra Leone for the year 1992 to 93.

NOW, THEREFORE, PURSUANT to paragraph 3 of the Proclamation
entitled "The Administration of Sierra Leone National Provisional
Ruling Council Proclamation, 1992", published in the *Gazette* on
the 4th day of May, 1992, the National Provisional Ruling Council
hereby makes and issues the following Decree:—

1. This Decree shall be deemed to have come into operation on the 1st day of July, 1992.

2. The sum of forty-eight billion, nine hundred and forty-five million, four hundred and sixty-three thousand, four hundred and thirty-one leones shall be and is hereby granted to the National Provisional Ruling Council for and during the year 1992 to 1993 and which sum shall be applied and expended in the manner described and for the several services set forth in the Schedule.

3. The sum of forty-eight billion, nine hundred and forty-five million, four hundred and sixty-three thousand, four hundred and thirty-one leones shall be and is hereby declared to be charged upon and made payable from and out of the Consolidated Fund for the year 1992 to 1993 and the payment thereof shall be taken to begin and commence on and immediately after the first day of July, 1992.

4. The Accountant-General is hereby authorised and required from time to time upon the Warrant or Order of the Minister of Finance, Development and Economic Planning to pay out of the Consolidated Fund for the several services specified in the Schedule the sum of forty-eight billion, nine hundred and forty-five million, four hundred and sixty-three thousand, four hundred and thirty-one leones which shall come in course of payment during the year ending on the thirtieth day of June, 1993.

5. The amount from time to time paid for and in respect of the expenditure authorised in section 2 shall not exceed in the aggregate the sum of forty-eight billion, nine hundred and forty-five million, four hundred and sixty-three thousand, four hundred and thirty-one leones from the first day of July, 1992 inclusive and any balance remaining unissued at the end of June, 1993, shall lapse and not be available for making payments in the following year.
