made by the Governor in Council under section 13.

1. These rules may be cited as the Business Names Registration Rules. Citation.

2. Forms A and B in the First Schedule shall be the prescribed forms for the purposes of section 4 of the Ordinance, and shall be furnished to the Registrar General in duplicate. First
Schedule.

3. (1) The certificate of registration to be delivered by the Registrar General under section 8 of the Ordinance shall be in Form C in the First Schedule.

(2) Every such certificate shall be prepared and signed in original and duplicate and the duplicate shall be retained by the Registrar General and filed by him. Such duplicates so filed shall constitute a register of certificates.

4. The fees set out in the Second Schedule shall be payable to the Registrar General. Second
