ROAD TRAFFIC ACT, 1986

THE ROAD TRAFFIC (AMENDMENT) REGULATIONS, 1986

Short title.

In exercise of the powers conferred by section 56 of the Road Traffic Act, 1964 (Act No. 62 of 1964) on the President and acting in accordance with the advice of the Cabinet the following Regulations are hereby made—

1. These Regulations shall come into force on the 22nd day of September, 1986. Commence-
ment.

2. The Road Traffic Regulations, 1960 (P.N. No. 77 of 1960) are hereby amended by the insertion immediately after regulation 12 thereof of the following new regulation— Regulation
12A of P.N.
No. 77 of
1960 inserted.

“Fee for international Certificate for Motor Vehicles. 12A. The fee for the issue of an International Certificate for Motor Vehicles shall be Le90.00”.

3. For rule 15 of the principal Regulations there is hereby substituted the following new Regulations— Rule 15 of
principal
Regulations
replaced.

“Replacement of defaced, faded, lost or stolen licences. 15. (1) Where the holder of a current licence issued under this Part satisfies the licensing authority that the licence has been defaced or mutilated or that the figures or particulars thereon have become illegible or that the colour has become faded, then the licensing authority on payment of a fee of five leones, shall issue a new licence which shall have the same effect as the original licence which shall be surrendered and cancelled.

(2) Where the holder of a current licence issued under this Part satisfies the licensing authority that the licence is lost or stolen, the licensing authority on payment of a fee of five leones or the licence fee originally paid, whichever is less, shall issue a new licence which shall have the same effect as the original licence.”

Regulation 22 of principal Regulations amended.

4. For paragraph (ii) of subregulation (9) of regulation 22 of the principal Regulations there is hereby substituted the following new paragraph—

“(ii) A fee of Le60.00 shall be paid before the applicant is entitled to receive the licence or renewal thereof and a fee of Le120.00 shall be paid for the issue of an international driving licence.”

Regulation 24 (1) (e) of principal Regulations replaced.

5. For paragraph (e) of subregulation (1) of regulation 24 of the principal Regulations there is hereby substituted the following new paragraph—

“(e) a fee of five leones shall be paid by the applicant for a duplicate licence.”

Revocation.

6. Regulations 5 and 6 of the Road Traffic (Amendment) Regulations, 1984 (P.N. No. 21 of 1985) are hereby revoked.
