## *THE LOCAL GOVERNMENT ACT, 2004 (Act No. 1 of 2004)*

### THE KOIDU-NEW SEMBEHUN CITY COUNCIL (ESTABLISHMENT) ORDER, 2006.

Short title.

In exercise of the powers conferred upon him by subsection (2) of section 2 of the Local Government Act, 2004, the President acting on the recommendation of the Minister of Local Government and Community Development, the Minister of Finance and the National Electoral Commission hereby makes the following Order:-

1. (1) The area specified in the Schedule is hereby declared a locality. Declaration of locality.

(2) The locality shall be called the Koidu-New-Sembhun City.

2. The Koidu-New Sembhun City shall have a Council which consist of - Establishment of Council.

- (a) the Chairperson who shall be called "Mayor";
- (b) eleven other members elected from wards in the Koidu New-Sembhun City; and
- (c) the Paramount Chief of Gbense and Tankoro Chiefdoms.

3. The principal offices of the Koidu-New-Sembehun City Council shall be in Koidu-New-Sembehun City.

4. In addition to the functions conferred by paragraphs (a) to (j) of subsection (2) of section 20 of the Act on the Koidu- New-Sembehun City Council, the Koidu-New Sembehun City Council shall perform the following additional functions under paragraph (k) of that subsection:-

(a) collection and disposal of refuse and the upkeep of the Koidu-New-Sembehun City in a clean and habitable state; and

(b) provision and maintenance of -

(i) parks, gardens and cemeteries;

(ii) recreational facilities;

(ii) community radio broadcasting.

5. The Koidu-New Sembehun Town Council (Establishment) Order, 2005 is hereby revoked.
