BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the House of Representatives in this present Parliament assembled, and by the authority of the same, as follows:—

1. The Freetown Municipality Act, the Rural Area Act, the Sherbro Urban District Council Act, the Bo Town Council Act, and the Townships Act, are hereby amended by substituting in the provisions of these enactments set out in the First Column of
