THE CUSTOMS TARIFF (AMENDMENT OF THE THIRD SCHEDULE)
ORDER, 1987

In exercise of the powers conferred on him by Section 10 of the Customs Act, 1978 (Act No. 16 of 1978) the Minister of Finance hereby makes the following Order:

1. This Order shall be deemed to have come into force on the 10th day of February, 1987.

2. The Third Schedule to the Customs Tariff Act, 1978 is hereby amended by varying the existing rates of duty under the following tariff item Numbers to read respectively:—
