The 1982/83 Appropriation Act, 1982

Short title.

Being an Act to provide for the Service of Sierra Leone for the year 1982/83

[1st July, 1982.] Date of Commencement.

WHEREAS it is necessary to make provision for the Service of Sierra Leone for the year 1982/83:

BE IT THEREFORE ENACTED by the President and Members of Parliament in this present Parliament assembled, as follows:—

1. This Act shall be deemed to have come into operation on the 1st day of July, 1982. Commencement.

2. The sum of Two hundred and Twenty-two Million Five hundred and sixty-five thousand Six hundred and Ninety-two leones shall be and is hereby granted to His Excellency the President for and during the year Nineteen Hundred and Eighty-two/Eighty-three and the same shall be applied and expended in the manner herein described and for the several services set forth in the Schedule.

3. The said sum of Two hundred and Twenty-two Million Five hundred and Sixty-five thousand Six hundred and Ninety-two leones shall be and is hereby declared to be charged upon and made payable from and out of the Consolidated Fund for the year Nineteen Hundred and Eighty-two/Eighty-three and the payment thereof shall be taken to begin and commence on and immediately after the first day of July, Nineteen Hundred and Eighty-two.

4. The Accountant-General is hereby authorised and required to pay out of the Consolidated Fund for the several services specified in the Schedule such sums as may be specified in the Warrant or Order of the Minister of Finance issued from time to time up to the total sum of Two hundred and Twenty-two thousand Five hundred and Sixty-five thousand Six hundred and Ninety-two leones which shall come in course of payment during the year ending on the thirtieth day of June, Nineteen Hundred and Eighty-three.

5. The amount from time to time paid for and in respect of the expenditure authorised in section 2 shall not exceed in the gross the sum of Two hundred and Twenty-two Million Five hundred and Sixty-five thousand Six hundred and Ninety-two leones from the first day of July, Nineteen Hundred and Eighty-two inclusive, and any balances remaining unissued at the end of June, Nineteen Hundred and Eighty-three shall lapse and not be available for making payments in the following years.
