THE INCOME TAX (CLEARANCE) (FEES) ORDER, 1995

Short title.

In exercise of the powers conferred upon it by section 14 of the Income Tax (Clearance) Act, 1992, as adapted by paragraph 5 of the Proclamation entitled "The Administration of Sierra Leone (National Provisional Ruling Council) Proclamation, 1992", the National Provisional Ruling Council makes the following order:—

1. The fees payable for the issue of an income tax clearance certificate and a written statement shall be as set out in the Schedule. Fees.
